

Paraders' Grant Program

The Parader's Grant was established by the CSHA State Parade Program in 1992. While the original concept was to award a grant to an organization that provided a "parade experience" for their handicapped riders, today the "parade experience" requirement has been dropped and we look for an organization that provides an on-going riding program for physically and mentally handicapped people in the State of California. Affiliation with CSHA is not required.

The exact amount of the grant is determined yearly based on the funds raised by the Parade Committee and may be used for any purpose related directly to the organization's work in this field.

Over the years, under the guidance of Peggy and Harry Narducci, funds have been raised by the Parade Program and donated to worthy groups. Following the passing of Peggy and Harry, the Parade Program has continued funding the Paraders' Grant in their memory. There are many people who need our help. It is gratifying to know that there are so many horses and people who are willing to spend the time and effort to help these individuals. We owe them a debt of gratitude. The Paraders' Grant is a wonderful way that all of us can help.
