RESOLUTION #G 2

GYMKHANA, SEC. 8.0 Types of Divisions, rule 8.4 Average Time Division, sub rules 8.4.7.2 and 8.4.7.3 and 8.4.7.3.1

WHEREAS, the dates in these rules often fall on the Labor Day week-end when a number of shows are held, and;

WHEREAS, deleting a combination from the Rating List Saturday night means they have to ride in Open on Sunday which causes a lot of confusion and frustration, and;

WHEREAS, a number of the deleted combination's attain their Current Year Rating by September 15th (end of the point year) and have to be added back onto the list causing more confusion and work;

Therefore, Be It *Resolved* that GYMKHANA, SEC. 8.0 Types of Divisions, rule 8.4 Average Time Division, sub rules 8.4.7.2 and 8.4.7.3 be amended as follows, and 8.4.7.3.1 be deleted.

8.4.7.2 The YER shall be valid through September 20th of the following year.

8.4.7.3 On September 21st, every combination that has not received a Current Year's Rating (CYR) shall be dropped from the Rating List.

~~**8.4.7.3.1** After September 1st, and on or before September 15th if a combination that was dropped from the Rating List receives a CYR the combination will not be placed in a division that is lower than their YER.~~

Funds for awards must be donated and handled by the event manager.

Funds may not be deposited into or checks be written out of the State Championship Show's account.to cover expenses

Delete 17.2.7.1 in its entirety and replace with:

Awards are at the discretion of the event manager. Awards must be donated. Awards must be ordered and/or purchased by the event manager.
