Resolution DT 1 Drill Team, Sec. 1.0 General, Sub Sec.1.9

WHEREAS, the consequences for some rule infractions are not addressed in the current rules, and;

WHEREAS, assessing of penalty points for unspecified infractions and the stating of procedures regarding potential disqualification should be clarified;

Therefore Be It Resolved that Drill Team Sec.1.0 General, Sub Section 1.9 be added as follows:

- 1.9 The consequences of any infraction of a rule not currently specified will be addressed by a vote of the competition judges with a vote by the show manager added only if necessary to break a tie vote. Penalty points will be determined by the severity of the infraction. A disqualification will only be assessed by a unanimous vote by all judges and is to be considered only in the most grievous circumstance.
