**Resolution #G 8**

**Gymkhana, SEC. 15.0 State Championship Show, rule 15.3 Eligibility, sub rule 15.3.4**

WHEREAS, the original intent of the Top 5 was to limit the show to the best of the best, and;

WHEREAS, the exclusivity and prestige has changed the show from a State Championship event to an open show, and;

WHEREAS, most Regions do not have ten combinations in each divisions thus riders do not support all shows because they know, under the current rule, they will “qualify” to compete at State;

Therefore be it *Resolved* that Gymkhana, Sec. 15.0 State Championship Show, rule 15.3 Eligibility, sub rule 15.3.4 be amended to read:

**15.3.4** The combination must finish in the top five (5) of their division.

Be it further resolved that if this resolution passes any and all rules that contain Top 10 will be changed to Top 5.
